ACCOMPLISHMENTS **FY 22**

GOVERNMENT ADVOCACY

1. Met with Miles Baker (Alaska's point person for distributing the IIJA funds) to establish relationship with funding sources.
2. Met with the MOA purchasing director to discuss MOA's purchasing practices.
3. Established relationship with Matt Reiffer, Vice President, Infrastructure Programs, ACEC National.
4. Established an ACEC/DOT&PF Steering Committee with the DOT&PF Commissioner, Deputy Commissioner, the three Regional Directors and the Chief of Contracts.
5. Ongoing communications with local governments about the benefits of using QBS.
6. Coordination with National for QBS reports and background information.

POLITICAL ACTION

1. Hired lobbyist to address issues important to the Alaska engineering community.
 - Met with former Governor (and current gubernatorial candidate) Walker to discuss his position on IIJA and the public workforce.
 - Attended fly-in in Juneau to meet with state representatives and senators regarding issues important to the design community.
 - Testified in Juneau on the Data Coordinate System.
 - Advocated for professional licensing modifications at the legislature.
2. Raised funds for National candidates through ACEC PAC.
3. Sent letters and attended meetings with our U.S. Representative and Senators regarding issues important to the engineering industry (e.g. grant language precluding design, IIJA, Davis-Bacon wages, PPP loan forgiveness and IDCR impacts, DOT lump sum billing terms, etc.).
4. Met with Senator Murkowski to discuss her position on IIJA and the public workforce.

BUSINESS EDUCATION

1. Additional outreach to the engineering community through affiliates (e.g. IT companies).
2. Provided training sessions on a variety of topics:
 - Network security
 - National resources and updates
3. Improved the salary survey.
4. Hosted national representative speaker (Gary Hartong).
5. Established relationship with Local Technical Assistance Program (LTAP) coordinator for DOT for coordinated training opportunities.
