Jim Hemphill Becomes 65th ACEC OKLAHOMA Chairman of the Board

Jim Hemphill, Vice President of Poe and Associates, Tulsa, assumed the leadership of ACEC OKLHAOMA as the 65th Chairman of the Board at the conclusion of the Annual Convention on June 8th.



Jim earned his Bachelors of Science in Civil Engineering from Oklahoma State University in 1981, and received his Masters of Science in Civil Engineering in 1997.

Hemphill has 38 years of experience in engineering, including 24 years with Poe and Associates and 10 years with the City of Tulsa. Prior to his career with the City of Tulsa he spent seven years with Hemphill Corporation conducting geotech-

nical investigations, foundation inspections and overseeing construction materials testing.

During the past 38 years he has primarily focused on infrastructure rehabilitation and facility management systems for both local roadways and major highways. He has also been responsible for implementation and updating pavement management systems for both the City of Tulsa and the Oklahoma Turnpike Authority.

During the Annual Meeting, the Budget Committee presented the proposed 2019-2020 ACEC OKLAHOMA Budget., and recommended that there be no increase in ACEC OKLAHOMA dues for the coming year, although there is a slight increase in ACEC national dues (.80%). The Budget was unanimously approved by the Board and Membership.

As his last act as Chairman, Keith Angier appointed John Bowman, Poe and Associates, and Kevin Kreiwall, Craig and Keithline, to the ODOT/ACEC OKLAHOMA Partnering Steering Committee. Bowman and Kreiwall replace Brent Schniers and David Streb, who's terms expired.

2019 Legislative Session Wrap Up Report

The 2019 Session of the Oklahoma Legislature drew to a close on Thursday, May 23rd, eight days ahead of the Constitutional deadline.

Needless to say, this was a much tamer session than last year when the Legislature dealt with begin in regular and special session for almost 18 months, and faced both a deficit budget and a prolonged teacher walkout.

With increased revenues, a new Governor, super-majorities for the Republicans in both houses, and a minority party which saw new leadership in both the House and Senate, there seemed to be a much needed willingness to work together from both sides of the rotunda and on both sides of the aisles. That's not to say that there wasn't controversy and that everyone sat around an sang "Kumbaya" for the entire session. But, it was very evident that this session was more "hand in hand" than "fist against fist."

As for the new Governor, Mr. Stitt got most of the major issues on which he campaigned last fall. From Government Reform by receiving the authority to appoint agency heads and governing Boards; a teacher and state employee pay raise; enhanced government transparency; and, putting money in a new state "savings" account, the first year Governor had a very good year.

Additionally, he got a taste of governing...remember, he had never held any type of public office prior to becoming Governor...by doing everything constitutionally possible when dealing with bills sent to him.

All in all, of the 2,899 bills and resolutions introduced this session, 535 bills and joint resolutions were sent to the Governor for consideration. Stitt signed 515, issued one line-item veto, vetoed 16 completely, allowed 2 bills to become last without his signature, and signed 2 joint resolutions.

As for ACEC OKLAHOMA and the engineering profession, it was an interesting year, and in the long run, a good year.

We fought a lot of battles early in the session, killing legislation which would have been devastating to the consulting engineering profession, while at the same time helping to protect the ROADS funds, get additional funding into the CIRB program, and assuring that there was no statutory restrictions placed on the use of Drones by engineers and land surveyors.

There were three specific bills we discussed in the last update, so here's how those ended up.

** Senate Bill 376 - Oklahoma First. This bill would give a "preference" in the awarding of highway construction contracts under the Competitive Bidding Act to Oklahomaowned businesses over out-of-state businesses.

While the bill dealt strictly with construction, ACEC OK-LAHOMA was concerned that it could eventually be expanded to the QBS engineering selection process based on comments made by the Senate author.

The bill did pass out of a House Committee, but was never considered by the full House prior to a late-April deadline, making the bill "dormant" for the session.

Technically the bill is still "alive" as a "carry-over" for the 2020 session, but it's very rare that carry-over bills are considered during the next session.

That being said, it's not unusual that similar or exact new bills are introduced the following session, and, in many cases, Interim Studies are requested for these carry-over bills. So, we will keep a close eye on the Interim requests being filed in the next couple of weeks to see if this issue is discussed more in-depth sometime later this year.

House Bill 2666 - Construction Management at Risk. For several months, ACEC OKLAHOMA has been working with the AGC Builders Chapter and a variety of other stakeholders as they seek to update the current statutory language regarding Construction Management at Risk (CMAR).

ACEC OKLAHOMA's interest in the bill deals strictly with proposed changes to current statutory language. Due to confusion regarding CMAR, which is a "delivery system," and Construction Management, a "service" provided by design professionals to their clients, new definitions are being proposed which would clearly delineate the difference between the "delivery system" and the "service" and which ACEC OKLAHOMA assisted in writing.

ACEC OKLAHOMA supported the bill, but at the same time, we remained diligent in making sure that any changes did not negatively impact the QBS process or the "services" which engineering firms provide their clients.

All in all, a "clean" bill came out of Conference Committee, passed both the House and Senate, and Governor Stitt signed this bill.

*** House Bill 2676 - Additional Funding to the CIRB Fund. This bill authorized, in addition to the regular annual appropriation, an additional \$30 Million into the CIRB fund to make up for CIRB funds which have been reduced in the past due to the Budget crisis of recent years. This ACEC OKLAHOMA supported bill passed the two chambers, and was signed by Governor Stitt.

Secretary Gatz Fills Three Key Positions

Two women are making an impact on the Oklahoma Department of Transportation by being named the first females in two top senior staff positions. Secretary of Transportation Tim Gatz named Dawn Sullivan as Deputy Director, and Terri Angier to the newly created position of Interagency Liaison. Additionally, Trenton January was selected as the Division Four Engineer, which includes the Oklahoma City metro.



Sullivan made history not once but twice by being the first female to attain the second highest position for the Oklahoma Department of Transportation and the first female to fill a senior staff position for the department. She has been working closely with outgoing Deputy Director Russell Hulin and will fully take the responsibilities after his retirement June 30. In this senior staff position, Sullivan will oversee all day-to-day administration and strategic planning for the department. She has a Bachelor of Science degree in Civil Engineering from the University of Oklahoma and has been a Professional Engineer since 1995.

Angier's new position is the secretary of transportation's direct report serving as Interagency Liaison for ODOT, Oklahoma Turnpike Authority and the Oklahoma Aeronautics Commission. She also will continue her responsibilities as Chief of the Media and Public Relations Division of the Oklahoma Department of Transportation. Born in Tehran, Iran, Angier obtained her secondary education in India and England. She earned a bachelor's degree in Anthropology and a master's degree in Journalism, both from the University of Oklahoma.

January was selected the Division Four Engineer in June. In this position, he will oversee the highway maintenance and construction activities for the nine counties in north-central Oklahoma, including the Oklahoma City metro. January earned a bachelor's degree in Civil Engineering from Oklahoma State University and currently resides in Stillwater.
