ACEC/SD and SD DOT Meeting News

In April 2015, ACEC Member Organizations were invited to participate in a nationwide academic study that compared the costs of performing engineering work by in-house DOT staff versus contracting it out to private engineering firms. Twenty-nine states, with South Dakota (six ACEC/SD firms) as one of the states, participated in the study.

The results of the final study, which was conducted by New York University, were recently released to the ACEC/SD board of directors. The results indicated a demonstrable savings by contracting out to the private sector. "Average salaries in the private sector were shown to be higher than those in the DOTs, confirming commonly held assumptions that existed prior to the study. However, the bigger costs paid for by taxpayers relate to overhead expenses, and in this category the study highlighted very pronounced differences between agency overhead rates and those of private engineering firms."

The board invited SD DOT Secretary Bergquist to meet to review the outcome of the study and, on December 1, 2016, Terry Helms, Gail Boddicker and Gregg Spagnolo, ACEC Vice Chair met with Secretary Bergquist and his team members—Joel Jundt, Mike Behm, and Greg Fuller to provide them with the details of the study.

The DOT asked for time to absorb the data and requested a possible future meeting to discuss the report in greater depth.

Other issues discussed included:

Rail + Aviation commissions may have some questions regarding the difference in costs of projects that use federal funds;

Joel asked if ACEC would be available to attend the airport conference scheduled for March to educate constituents on complying with regulatory requirements on public sector projects;

ACEC needs to engage with DOT on the QBS changes;

FTEs at the DOT are capped and the DOT will be needing the private industry's expertise:

100% of the BIG projects will be contracted out;

ACEC members are committed to partnering with DOT on the TRAC, TAC and STIP programs.

ACEC/SD and Agreed Upon Procedures

Ketel Thorstenson, LLP, Certified Public Accountants in Rapid City, were recently contracted with by the ACEC/SD board of directors to assist the association in respect to the financial records for the year ending June 2016.

The final report was presented to the membership at their December 1, 2016, meeting. Nina Braun, CPA, CFE, Partner at Ketel Thorstenson, LLP, presented the following Findings::

1. Review of Internal Controls

We recommend the Treasurer continue to review the bank statement each month. This should include a review of cancelled checks for appropriate vendors, amounts, and signature. The deposits included on the bank statement should be reviewed and agreed to deposit summaries outlining the details of each deposit. This will assist in preventing misappropriations of Council assets and identifying any possible accounting related errors.

2. Insurance

We recommend that the board be involved annually in the review of insurance coverages. The board should be aware of the levels of coverage over the Council's operations.

3. Payroll

We recommend that the board review and agree to an updated contract with the Executive Director. The Council should maintain a signed copy of the contract to agree to future invoices.

No Findings were noted on the following:

Selected two months during the year ended June 30, 2016, and verified cash balances on the general ledger agreed to bank statements and reconciliations.

Selected 20 disbursements from the general ledger detail for the year ended June 30, 2016, and agreed to supporting documentation and cancelled check images.

We walked through the cash receipt process for 10 deposits made during the year ended June 30, 2016, and agreed cash received per QuickBooks to the respective bank statements.

Nina reported that the report is very positive and that the organization is doing a nice job with the financial controls.
