### What is causing most delays?

- o Changes to design after ROW begins plan development.
- o Properties are owned by multiple people.
- o Property is in probate, liens, and mortgages

#### Process for changes caused by negotiations

 Change order is sent to designer. This has to go through the process of doc's, appraisal etc.

Process during construction when changes are discovered that affect the rights that were acquired?

- Simple-construction can handle temporary rights
- o Complex-ROW gets involved to prepare documents and compensation

#### Who resets property monumentation

- If VTrans resets the PO assumes that is their corner. VTrans is not going to reset IP's.
- VTrans will be paying the PO to have it reset. If iron pipe it will be reset, generally by the contractor.
- o Contractor reset-Trying to move toward contractor resetting pins.
