Lots still up in the air regarding increase inf Federal funding

Potential for Approx. \$150 M additional funds in the federal authorization, per year of the 5-year authorization (not a separate one-time stimulus package). Same rules apply for State match. Flexibility being discussed on allowing funds to be spent beyond the fiscal year (remaining tied to the per-year authorization).

Performance

On-time Delivery for 2021 – 74%

Alternative Project Delivery – CMGC and Design Build Project Forecasting

Potential for a handful of DB projects coming (large culverts, complicated roadway projects). VTrans will outreach to consultants in October for assistance with getting these out.

New process to assure that subconsultants are formally approved before invoicing. Also need to check and update the firm contacts where needed. Need approval for ALL subs, regardless of size or type.
