# Meeting Minutes June 8, 2022

# Featured Presentation (10:05 to 10:40)

- MicroStation CONNECT OpenRoads Update Mike Longstreet
  - o VTrans working Group / CAD Committee
  - Workspace updates / refinement
  - CONNECT software updates & implementation VTrans is adopting updates on a rolling basis as MicroStation provides. Goal to keep workspace as simple as possible and not customizing when there is no need.
  - Agency Plans going forward
    - i. Goal to have Digital Data delivery for projects to selected Contractor within next 2-3 years. More information on what this will look like and how it impacts consultants by this winter.
    - ii. Goal to deliver a full Digital Model for bidding in 3-4 years.
    - iii. Future discussion around As-Builts and who is responsible for updating Models (it is likely the Designer will be retained for this)

#### **General Meeting**

- VTrans Operations Rob White
  - Delivered more than half projects out to construction: 60 out for construction, 112 projects in the queue resulting in 86% out for construction on time.
  - VTrans has seen a few projects, mostly complicated and/or multi-year an night-work, with significantly higher bid costs (likely tied with inflation and risks that the Contractor may incur). Generally, VTrans has not seen a wide-scale impact of inflation on the project bids. Have seen some longer lead time. VTrans is watching the market supplies but haven't seen significant impacts of inflation on project bids.
  - o Some critical positions are still open but overall most of the staffing is under control.
  - Some issues with trucking availability. Some projects will be impacted with rising fuel costs.
  - o Allowed substitution products for stainless steel rebars based on availability and costs.
  - Question (Wayne Symonds) How is the availability of FRP reinforcement? Could we consider it during design as a substitute moving forward for decks?
    Answer (James Lacroix) Yes that this may be considered on VTrans projects coordinate with the VPM. Already seeing it on a few projects.

  - USDOT Discretionary Grants

Safe Streets and Soads for all (SS4A) – funds planning and projects. For towns and cities and MPOs to put together action plans. Once plans are complete they can apply for projects. Applications Due in September.

- o Build America, Buy America Act May 14, 2022 Implementation
  - Iron and Steel
  - Manufactured products
  - Construction Materials

Non ferrous metals, fibre optic, glass etc. there is a waiver available.

Guidance is under development anticipated to be done by Nov. 22.
